Year 7-10 Exams

We are aware of the impact that COVID-19 and the extended periods of lockdown have had on the knowledge and learning of the students. Therefore, we are making changes to the exams for Years 7 to 10 at the end of this year. Please see below. We will be producing exam timetables for students soon and will hand these out in form groups. Students will also be having exam launch assemblies where we will discuss the process of exams and give strategies for revision.

ShowMyHomework

We can also now confirm that we will be returning to ShowMyHomework for the setting of all homework from Monday 10 May. Many staff will still be using Teams to hold resources, and to facilitate the submission and marking of work, but all tasks will be signposted on SMH.

Covid-19 Testing
